COMES NOW JOE OR JANE DEFENDANT, having been made Defendant in the instant matter, who is unschooled in the practice and pleadings of law, state that I have first hand knowledge of the facts stated herein and those facts are true and correct to the best of my knowledge, information and belief; and file this Affidavit (with Exhibits) and show this court as follows:

1. I received a Demand letter from Heartless Attorney on or near December 15th, 2011. Said letter had been mailed to a former address where it remained unknown to me until this date.

2. I wrote a letter of dispute to Heartless attorney and caused it to be mailed on December, 30th, 2011. (see Exhibit A-1 and attached thereto a copy of the signed returned “green card” and receipt Exhibit A-2).

3. Having received no response from. Heartless Attorney, I wrote a letter of dispute to Evil Bank (USA), N.A. (hereinafter “EB”) and caused it to be mailed on January 12th, 2012. (see Exhibit B-1 and attached thereto a copy of the signed returned “green card” and receipt Exhibit B-2).

4. Having received no response from EB regarding the letter in #3 above, I wrote another letter of dispute to EB and caused it to be mailed on January 30th, 2012. (see Exhibit C-1 and attached thereto a copy of the signed returned “green card” and receipt Exhibit C-2).

5. Having received no response from Capital One regarding the letter in #4 above, I again wrote another letter of dispute to EB and caused it to be mailed on March 13th, 2012. (see Exhibit D-1 and attached thereto a copy of the signed returned “green card” and receipt Exhibit D-2).

6. I have reviewed the information contained in the foregoing Defendant’s Opposition to Plaintiff’s Motion for Summary Judgment and all of the information contained therein is true and correct to the best of my knowledge, information and belief. I state that I am the proper person with the most knowledge of the financial facts of this matter and make this certification.

7. Defendant denies all of Plaintiff’s allegations alleged in Plaintiff’s complaint including any alleged obligation to any amount owed claimed by Plaintiff, and to any agreement to pay pre-judgment interest, plaintiff’s costs, or post judgment interest.

8. Defendant denies becoming indebted to the plaintiff on any “account of goods and services rendered”, or “requesting” and having had “use of credit card within six years last past”.
